MINUTES June 7th, 2022

Meeting convened at 5:30 P.M. Board members present were Stan Pitchko, and Scott McCoy. Staff Present: Jennifer Polverari.

Board Reorganization: Motion was made by Scott McCoy to nominate James Lavallee as Chair Stan Pitchko seconds. Vote unanimous. Stan Pitchko nominates Scott McCoy as clerk. Scott McCoy seconds. Vote unanimous.

Minutes of April 26th were approved and signed. Vote unanimous.

Motor Vehicle:

A motion was made by Stan Pitchko and seconded Scott McCoy to accept the following Motor Vehicle and Trailer excise abatements and monthly lists from April 27th to June 7th.

Vote unanimous. Approved and signed.


Mrs. Polverari updated the Board that there would be a 3% increase this year and budget has been approved.
