The Finance Committee suggested the \$61,000.00 which would have been put into the stabilization fund will now be used to pay down the vocation tuition and transportation shortage. Mr. Williams is hopeful people will come out next Tuesday because questions are easily answered at these meetings rather than Town meeting. Selectman Moriarty stated Department Heads need to be at the May 2 meeting to answer questions about their budgets. Ms. Michonski informed him that they have been notified and it was also brought up at the Department Head meeting earlier in the day. Selectman Moriarty brought up the fact in the last two years there were COVID funds available whereas this year there is not and that this was coming our way but the COVID funds delayed what was going to happen inevitably.
